Dissertation Abstract

The Road to Development or Continuing Crisis? Structural Adjustment and Political Change in Sub-Saharan Africa

This dissertation explores the effects of structural adjustment programs on changes in the protection of personal security rights and participation in forty African states in the aggregate, and in Ghana as a case study. Structural adjustment loans, borrowed by the majority of Sub-Saharan African countries during the 1980s, were conditioned on governments making a certain number of economic reforms including currency devaluation, downsizing of the civil service, and the discontinuation of free social services.

The results of the research indicate that structural adjustment did indeed impact personal

security rights and political participation over time. In the short-term, the impact was largely negative: personal security rights abuse increased slightly, and participation rights were ignored in the adjustment process. Over time, however, the pressure from the World Bank and other lending institutions, combined with other international and domestic events, led to greater openness of many African societies and to greater opportunities for participation and the hope for an end to personal security rights abuse.
